TERMS AND CONDITIONS BOOKINGS

Tentative bookings will be held for 7 days, unless a non-refundable booking fee is received, of 50% of the booked package (not including the bond). Full payment must be made 14 days prior to the event. The booking is for up to maximum 35 attendees, excluding services, such as celebrant and photographer, and subject to prior agreement.

RESPONSIBILITY, DAMAGE & SAFETY

A \$200.00 bond will be added to your final invoice to cover any damages or clean-up that may occur during your event. This will be refunded within 7 days following your event should no damage occur and no additional cleaning was required. Waste left at the site (and not located in the bins provided) whether by you or the services you have hired to attend or supply your event, is your responsibility and will result in a minimum of \$100 being deducted from your bond. Anderson Point does not take any responsibility for the loss or damage to guests' property, including anything related to your wedding, or services of other vendors hired in for the day. Anderson Point provides paths and clearings for guests to ensure their safety, although the ground can be rough and gravel can be slippy. In order to maintain our beautiful surroundings and to minimise the risk of falls, all guests are to remain on designated paths at all times. Anderson Point is not to be held responsible for personal injury to any visitor anywhere on the property. It would be prudent to advise guests of appropriate footwear prior to your event.

WEATHER

Anderson Point does not offer a refund of the booking fee for inclement weather and as such suggests the following, should the weather be likely to affect your event:

- Free change of event date to another date, subject to availability.
- Hiring our Bedouin stretch tent as an additional extra. We would also strongly advise that clients include this extra for temperatures over 35 degrees.

NOISE

Anderson Point requests that noise does not impact our natural surroundings. As such we reserve the right to ask you to reduce the volume, and if this is not complied with, we reserve the right to ask you to leave the premises.

RESTRICTIONS

Smoking, naked flames, fireworks, sparklers, candles or any other potential fire risk are strictly prohibited in all areas by all visitors. Anderson Point reserves the right to retain the full bond if any visitors do not adhere to this restriction. Only natural biodegradable confetti is allowed, such as real rose petals or hole-punched leaves. Pampas grass and other seed-shedding-type plants are not permitted. Please specifically inform all guests and services prior to the event of these important restrictions.

CANCELLATIONS

Anderson Point would share in your disappointment if you need to cancel your wedding. All cancellations must be received in writing and will not be entitled to a refund of the booking fee. In addition to this, we reserve the right to charge a fee of the estimated total cost of the wedding as follows:

Cancellation within 14 days of the event: 25% of the full wedding cost Cancellation within 7 days of the event: 50% of the full wedding cost

Anderson Point must adhere to strict regulations in the highly unlikely event of a Fire Behaviour Index of 75+. In these conditions, Anderson Point has no other option but to cancel any event due to public safety. Due to this inconvenience, Anderson Point will either refund the full amount of the booking already paid, offer a new date, or endeavour to help find a suitable alternative if the client chooses to keep the existing date.
